# NCW approves the agreement on the extension of maternity leave

The National Council of Women (NCW) is pleased to note Government's successful efforts to reach agreement on the extension of paid maternity leave with the social partners within the MCESD. In this agreement, which has been approved by the Employment Relationships Board, the extension of maternity leave by four weeks spread over a period of two years, will be paid by Government with a fixed amount of 160 euros per week

NCW sees this development as another important step after the publication of the Legal Notice regulating Temping Agencies which came into force on the 5 December 2011. Employers also stand to gain by this measure as they will be able to employ trained personnel on a temporary basis when workers are on long leave, in this case mothers before and after they have given birth.

This reflects the importance that is being given to the health aspect of working mothers as not only will mothers be in a position to stay longer with their newborn at such a critical time but will also be able to breastfeed for a longer period . NCW is also pleased that mothers will be in a position to choose whether or not to do overtime during pregnancy and up to one year after childbirth - another important health and safety measure for working mothers

NCW is satisfied that consensus has been reached, after its efforts during the past months, discussing its proposals with social partners, which also took into consideration the needs of employers. The Council is pleased that its proposals for Budget 2012 will come into force on the second December 2012.

# 2011 Council of Europe Exchange on the religious dimension of intercultural

The Committee of Ministers of the Council of Europe organised the 2011 Exchange of intercultural dialogue on the 28 and 29 November 2011 in Luxembourg at the Abbaye de Neumunster, historically renowned for its role in bringing peoples together.

The exchange brought together experts representing media professionals, religious communities and representatives of non-religious communities including women's organisations. The theme chosen for this event was "Media, beliefs and religions - the role of the media in fostering intercultural dialogue, tolerance, and mutual understanding" This event was a follow-up on CoE exchanges since 2008.

The objectives of this event were to continue the debate on media ethics with regards to religious beliefs and sensitivities as well as non-religious beliefs. The three themes debated were 'Expression in the media of society's religious and non-religious convictions – the respective role of the traditional and the new media'. The debate addressed significant challenges such as hate speech, segregation and stereotyping. The discussion also addressed a number of issues on access and control of the media, democratic representation and the risk of strengthening divisions and fragmentations of society.

The second theme 'Place, image and discourse of women with religious and non-religious beliefs' centred on women's issues and the conflicts which arise from the right to freedom of religion and the right to gender equality – two fundamental rights that

Immigration today is resulting in families which have grown up in a model where sexes are sealed off from each other moving into a society where the male-female worlds permeate each other. The role of the media to support the transition from one culture to another is crucial.

The third theme dealt with 'Building bridges based on common values – the role of education'. The primary objective of intercultural dialogue is 'living together as equals in dignity'. This sharing and building requires proper awareness to be able to exercise critical thinking on the basis of reliable data and objective information. It means distinguishing between shared convictions and personal beliefs. It requires training in media analysis and criticism.

Alongside professional journalists, new media opens up numerous sources of information and allows each and every person to launch messages into the public arena. The media can contribute to combating ignorance by using their power of communication to educate the public, in a formal and nonformal way. Better trained media professionals are needed to fight media stereotyping or erroneous interpretations of religions, in particular on how to better highlight the valuable role of women as actors in intercultural

dialogue

In conclusion, this Exchange supported to the adoption by the Committee of Ministers of the Council of Europe of necessary measures as follow-up to the proposals put forward by the Parliamentary Assembly, in its recommendation 1962 (2011) on the religious dimension of intercultural dialogue, promoting a genuine partnership and the recognition of a platform for dialogue between the Council of Europe and highlevel representative of religious and non-denominational organisations

## **The Price of Motherhood**

A seminar on research findings by NSO and Centre for Labour Studies, Lecturer Anna Borg on the relationship between female employment and fertility rate in Malta was held on the 24 November 2011 at the Westin Dragonara Hotel St Julians.

The objectives of the research study were to provide evidence to interpreting the current employment/fertility situation in Malta which traditionally view female employment and fertility rates as being inversely related.

The research study challenges these theories and contends that education, social norms, work flexibility and family support structures are among the factors that moderate the relationship between female employment and fertility rates in Malta.

The study provides evidence on how higher investment in female education is leading to greater opportunity costs in having children, thus delaying childbearing. Social norms, that is traditional gender roles in higher asymmetric division of unpaid work as well as a negative view of formal childcare are also key obstacles to women to join the labour market together with work flexibility and family support structures.

The study has been carried out on three categories of mothers:

- Career mothers: in employment with the same employer between 2000 and 2009
- Drifting mothers: changed their employer and moved in and out of the labour market between 2000 and 2009
- Non-working mothers: do not have a registered employment history with the ETC.

# A number of findings reveal amongst others that

- Whereas the total number of male employment increased by 7.5% between 2000 and 2010, total female employment increased by a much higher 28.1% over the same period (NSO)
- The share of Maltese 21year-old females enrolled in

tertiary education increased substantially from 22% (of all 21-year old females) in 2000 to 32% in 2009 (Eurostat)

The higher the average wages of occupations, the greater the number of days worked by drifting mothers. Thus drifting mothers work more days if they are employed in technical, professional; or managerial jobs compared to plant operators, crafts persons, sales workers and those in elementary occupations

Overall the increase in the average worked days from 35% to 50% would result in an additional euro 18.5 million per year in household income and an increase in euro 5.1 million in government tax revenue (social security contributions and income tax)

# AMIE Project Exposure during Girl Guides Annual National Conference 2011

Nadya Anne Mangion was invited by Ms Marjoe Abela Chief Commissioner of The Malta Girl Guides Council Malta to promote AMIE Project during the Girl Guides Annual National Conference held at the Fortress Suite Corinthia San Gorġ Hotel St Julian's on the 19th November 2011.

AMIE being the acronym for Ambassadors in Malta for Increasing Women Entrepreneurs as well as the French word for female friend. National Council of Women Malta together with Foundation for Women Entrepreneurs (FWE), Reach Beyond Foundation, Malta Business Bureau (MBB) and Malta Association of Women in Business (MAWB) have obtained funds from the European Union's Competitiveness and Innovation Framework Programme for a project to promote female entrepreneurship in Malta through the establishment of a Network of Women Ambassadors. This project

has been in action since its launch in November 2010.

Much interest was shown during an interactive cafe' activity held during the conference. Girl Guide unit leaders asked for information about the project. Ms Abela had requested that unit leaders include talks by AMIE ambassadors in their three-month programme of activities to take place from January to March 2012. These ambassadors will be role models to inspire young girls to become entrepreneurs by 'telling their story'.

The AMIE team is preparing a number of interactive sessions to be able to convey the message of the project – girls and women can be entrepreneurs. The ambassador team will be targeting the Girl Guides sections made up of 10 - 13 year olds as well as the Rangers sections comprising 14 - 18 year olds.

Girl Guides are usually faced with the requirements of fund-raising;

## NCW targets Youth in Campaign on Domestic Violence

The National Council of Women (NCW) regards families as the backbone of a strong and healthy community and the establishment of loving supportive relationships from a young tender age as being the heart of happy, well functioning families. Contrastingly, relationships founded on fear and violence cannot sustain or nurture either partner or the family they might hope to raise. Parents too need to become more aware of the importance of a family environment that is conducive to the emotional development of children and youth

For this reason, NCW believes that there is a growing need to create more awareness of this problem of domestic violence amongst adolescents and youths, identifying early signs of domestic violence, placing particular emphasis on common patterns of controlling behaviour and abuse, such as signs of possessiveness, jealousy, put downs and humiliation, menace and threats.

These types of behaviour are all damaging to the youth's emotional development and are the cause of a lot of suffering both on the victim and the perpetrator. Some youths come to accept violence as the norm, thinking they deserve no better. Violence can become a learnt behaviour, destroying the youths' capacity to form healthy relationships.

The Council stresses the importance of educating youths by addressing these initial signs of domestic violence and offering opportunities to develop skills through preventive measures which are crucial for young people to take control of themselves and their situation and also to stimulate them to seek help from competent professionals as early as possible.

The Council also stresses the need to provide more adequate and effective education on the early signs of domestic violence in relationships of teenagers and young couples, in schools at primary, secondary and tertiary level. In this way, more emphasis would be placed on prevention and early intervention of the early signs of domestic violence, both if these predispose the youth to become a victim or an abuser.

For this reason, the National Council of Women is presently embarking on a prevention

campaign aimed at generating more awareness on the early signs of Domestic Violence amongst youths and possible measures which can be taken to address these problems. One aspect of the campaign will be to introduce youths to key professionals who can help them become be selfconfident. In this way youths are not only being educated on the matter, but are also being empowered to take action against Domestic Violence.

We believe that the local media has an important part to play in eliminating domestic violence and we rely on them to support this campaign

The project will be coordinated with Agenzija Zghazagh and will be running towards the beginning of the upcoming year. More information on this project will be published in the upcoming weeks. This project will reach out to adolescents and youths from secondary schools to tertiary level through a series of activities held throughout the year which will target youths as the main protagonists against domestic violence towards a better future.

On Saturday 12th November, the National Council of Women in Malta held its third EU Flagship Volunteering Conference at Dar L-Ewropa in Valletta. The theme for this conference was Intergenerational Volunteering: Paving the way for the EU Year of Active ageing 2012, bringing together youth, adults and the elderly. The purpose of the event was to promote the concept of voluntary work between different generations and to highlight the importance of coming together for a common cause, regardless of age.



The meeting opened with an introduction from NCW President Grace Attard who spoke about the active participation of the council in the European Year of Volunteering 2011, which is purposed towards encouraging and supporting the efforts of volunteers, whilst creating conditions conducive to volunteering and to increase the visibility of voluntary activities in the EU. She explained that the council work hours on end to create awareness through their organised events, in order to promote citizens' participation, breaking down barriers and reduce stigma.



Ultimately, she said that the broader scope of the EU Year for Volunteering 2011 is to promote a participative democracy and as such, assured participants that the data collected will be put forth to the Maltese Government and the European Commission.

Ms Attard also introduced the flagship project for next year, the EU Year for Active Ageing 2012, which is dedicated towards promoting an active lifestyle amongst the older generation, living with purpose beyond age limit and the importance of the contribution of all participants within society.

Following a short video clip which highlighted the theme of the meeting, that is the importance of dialogue between generations, Hon Dr Jason Azzopardi, Parliamentary Secretary within the Ministry of Finance, gave a very warm presentation of his personal experience in volunteering. Dr Azzopardi highlighted the fact that we can all be volunteers, simply by being aware of the needs of others and taking action up it.

He also spoke about the importance of bridging the gap between generation, mixing social groups, sharing the wealth of knowledge of experiences and practises. Dr Azzopardi emphasised that we should not quantify the value of volunteering but rather appreciate the fulfilment it provides, and thus added that many people are not aware of the personal benefits that are attained by doing voluntary work. We should take a leap into the dark and just go for it, he added enthusiastically.

On a broader context, Dr Azzopardi said that our society cannot have economic progress without sociological progress and vice versa. Everyone is important; we are all chained together and are all equally weak and equally strong. It is therefore our responsibility to strengthen this chain. He ended his speak with a sincere quote, "It is irrelevant whether I am running a country or a family, we must all work together towards progress".

The Meeting progressed with a presentation from Mr Moses Azzopardi, President of the National Association of Pensioners, who spoke about his initiatives at EU level and his influence on the EU Commission's communication on active ageing. Mr Azzopardi explained the scientific advantages to living a better lifestyle. Interestingly, he also said cross-bridged social factors such as the elderly having an adequate income would result

social factors included friendly measures at work for the elderly, which Mr Azzopardi believes could bring experience transmission between the age groups and thus, a stronger national workforce.

Ms Miriam Teuma, Agenzija Zqhazaqh Chief Executive gave an interesting presentation on youth and their needs and dreams, and how adults can help them 'connect'. Ms Theuma enthusiastically stated that when generations bridge together it is like fireworks.

Unfortunately, however, we have been brought up in a culture where, through segregation in our social system, we feel the generation gap more than ever. She highlighted how consequently, youth development is affected because they lack integral dialogue. More than ever, our society needs to develop horizontal bonds through intergenerational solidarity in order to sustain the strength of our communities.

We also need to breakdown stereotypes and re-establish our ancestors as our role models, rather than media icons; in order live role plays and the following

in better mental and physical to pass down values, traditions points and social messages.

Ms Vivien Cassar, family One of the most important therapist, gave a very lively presentation on relationships, particularly within the family and how the way we bring up our children can serve to develop a caring society of young people.

> How can I prepare the values for the next generation? She asked. Preparing strong values to pass on to the next generation, rather than prevent negative ones, is key.

> Intergenerational relationships also serve to the development of emotional intelligence; 'mattressing' society towards emotional disappointments and ultimately bring social strength.

> It is therefore down to us to change and be disciplined; get youths involved as we adapt to activities that they enjoy; to work with elderly rather than for the elderly; breakdown perceptions by taking the time to explain. After the presentations, NCW President Grace Attard challenged the attendees to think outside their margins and created a dynamic discussion that addressed the challenges, as well as the benefits of intergenerational dialogue. All the attendees were involved in 6



were raised:

- Empathising with youths
- Importance of dialogue
- Listen to youths rather than preach
- Alleviate pressure on youths by not expecting them to be the extension of our success
- Elderly sometimes perceived as a burden to family and society
- Do we reciprocate the care we received from the elderly when they were our quardians?
- Elderly may be comfortable in homes, they simply miss social interaction.
- Modernism continues to enlarge the gap between generations
- Technological knowledge can help elderly interact with society (such as Skype)
- Do elderly understand the generation gap? Or do we look down on youths because they live a more comfortable lifestyle?
- Do we focus on the content, or do we try to understand social gaps, by empathising for instance?
- Do we trust the abilities of the elderly?
- The importance of social inclusion
- Adapting social spheres for both young and elderly
- Do we empower our children to help the elderly?
- Need for quality time between generations.

The conference was indeed an experience of interaction and togetherness. It came to an end on a simple note: Let's reflect on our own behaviour and start from there.

# **European Initiatives**

## **Consumer Protection Laws**

#### **Rapporteur:** Mr Hernández Bataller

The Council and the European Parliament decided, on 19 and 18 January 2011 respectively, to consult the European Economic and Social Committee (EESC) under Article 114 of the Treaty on the Functioning of the European Union, on the Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 2006/2004 on cooperation between national authorities responsible for the enforcement of consumer protection laws COM(2010) 791 final - 2011/0001 (COD).

#### Main recommendations

At its 471st plenary session, held on 4 and 5 May 2011 (meeting of 5 May), the European Economic and Social Committee adopted the following opinion by 104 votes to 13 with 4 abstentions. While supporting the Commission's proposals to introduce greater legal security, certainty and clarity into EU legislation, the EESC makes a number of recommendations aimed at improving the workings of the current cooperation between authorities responsible for consumer affairs. The EESC considers the proposal to be too narrow and believes that it does not deal with many of the current issues affecting cooperation between consumer authorities. The following is a summary of these recommendations

#### **Systematic market** surveillance

The monitoring and inspection of goods and services regulated by EU legislation requires maximum joint planning in the programming of actions to be taken in each case by Member States' consumer authorities, both in terms of time and in terms of content.

#### **Penalty procedure**

corrective measures resulting from infringements of the EU legislation in force, there should be minimum harmonisation of the common criteria for the penalty procedure. These penalties would include:

- Appropriate types of administrative penalties for the breach of key provisions;
- Publication of serious penalties;
- High level of administrative fines, in accordance with the infringement committed;
- Criteria to be taken into account when applying penalties;
- Penalties for natural and legal persons;
- Possible introduction of criminal penalties for the most serious breaches:
- Appropriate mechanisms supporting effective enforcement of penalties.

#### **Quality monitoring of goods** and services

A common procedure must be established for monitoring with a view to harmonising its methodology. There must also be cross-border planning in order to extend the spectrum of monitoring, using the resources made available in each participating administration as efficiently as possible.

#### **Product safety**

The rapid alert system, could be improved as a complement to the implementation of tools and instruments for the identification, management and communication of risks, as happens in the case of food safety risks.

#### Consideration of ethical and environmental factors in the marketing authorisation of goods and services.

It is essential that the procedures relating to the aforementioned alerts be extended to products which must be withdrawn from In order to prevent a border the market for ecological, ethical

effect in the application of or other reasons relating to business practices that violate people's dignity or their environment.

#### **Promoting good business** practices in relation to responsible consumption

In view of the increasing importance and spread of Corporate Social Responsibility programmes, consumer policies must play a key role and consumers must be consulted for the purposes of the corresponding responsibility reports.

#### **Collective actions**

Collective actions for injunctions are regulated at Community level, although this does not currently include collective actions for compensation. In the event of serious infringements, the confiscation of unlawful profits resulting from infringements and punitive damages should be provided for as measures to accompany the penalty handed down by authorities and the resulting amounts should be paid into a "support fund for collective action", which would help consumers' associations to launch this kind of collective action for compensation.

#### **Alternative dispute resolution** mechanisms

The Commission has published a consultation document on "The use of Alternative Dispute Resolution as a means to resolve disputes related to commercial transactions and practices in the EU". In order to increase consumer confidence, consideration should be given to the possibility of establishing a "European label" for establishments and companies signing up to these systems.

#### **Resource networks** and hubs

#### Autumn General Assembly ECICW

ECICW celebrated its 50th anniversary as it was founded in 1961 in Axenstein. Switzerland. Doreen Micallef, Vice President NCW Malta, attended as the Maltese delegate.

The General Assembly was attended by delegates from France, Germany, Greece, Israel,

Italy, Lithuania, Malta, Monaco, Netherlands, Spain, UK, Ukraine, Slovenia and Switzerland. Lebanon has been accepted as member of ECICW and will attend future general assemblies. Cosima Schenk, president of ICW was also present.

In her president's speech, Doris Binaley outlined the work that has been achieved so far. She introduced ECICW to the European Institute of Gender Equality in Vilnius and to the Small States of Europe at their Congress in Liechtenstein. In Perth, Australia

she raised ECICW's visibility at the Commonwealth People's Forum during CHOGM where she made contact with ICW Council members from Africa, Asia and Australia. She presented ECICW at a meeting on volunteering in the province of Messina.

the United Nations Commission of the Status of Women March 2012. The National Councils reported on their projects and programmes they have been working on in the last six months.

During the meeting, Rosa Artigas of Spain was elected ECICW representative for EWL and Doris Bingley was elected as alternate.

At the end of the first working day a plan of action for 2012 was agreed. This was based on Europe 2020. Doris Bingley urged all National Councils to engage with stakeholders to build partnerships and promote quality assured education and training to empower women. Councils were advised to develop life- long learning programmes to enhance skills which include computer literacy and encourage entrepreneurship. By assisting women to achieve economic independence we help eliminate violence and poverty.

Friday 25<sup>th</sup> November being International Day for the Elimination of Violence against Women, ECICW issued a statement calling on European Institutions and Governments to take action by supporting National programmes and initiatives to eliminate genderbased violence, by focusing on prevention, protection and services, improve advocacy for women's empowerment and promote women's decision-making roles at all levels, especially in political and economic positions.

On the second day, the Swiss Council organized a seminar entitled 'Swiss Women in Society and Politics and the role of Women's Organisations'. The keynote speaker was Etiennette J. Verry, president of the Federal Commission for Women's Issues and past vice-president of Alliance Ms Verry spoke of the history F of women's rights in Switzerland, gave an overview of the actual situation of Swiss women in society and politics regarding equal opportunities and highlighted the role of women's organisations in society and politics. Switzerland was one of the last countries in Europe to allow women to vote and this was in 1972 although it was in 1971 that women were allowed to run for politics. Inequalities still exist between men and women in salaries, choice of profession, balance of power, balance of work and family, domestic violence and human trafficking. Women in top

management positions still make up less than 10%. Although quotas have proved to help boost these numbers in other countries, it is still difficult to even to talk about them in Switzerland.

A discussion and workshop followed about the situation of women in society and in politics in the participants' countries and how these countries are trying to motivate women to actively participate in politics.

The seminar ended with the presentation by Valentyna Semeniuk-Samsonenko, head of the Ukrainian NGO 'Ukrainian Women for Children's Future' and president of the Ukrainian National Council of Women. The National Council of Ukraine consists of 36 organisations which in total represents 5 million women. She spoke of the role of social organisations in the explanatory work on a healthy way of living and how her organisation actively educates men, women and children about such themes as drug abuse, the dangers of abortion, food and water safety to avoid radiation contamination, etc.

# Commonwealth People's Forum provides crucial interface between governments and civil society

Perth, Western Australia hosted the Commonwealth People's Forum (CPF) from 25th to 27th October 2011 in the run up of the Commonwealth Heads of Government Meeting (CHOCM) from 28 to 30th October 2011. These meetings are held every two years.

Civil society representatives gathered in Perth to discuss and debate key issues facing Commonwealth People. The theme of this year's Forum was "Driving Change for a Dynamic Commonwealth"

The Forum was officially opened by the Hon. Julia Gillard MP, Prime Minister of Australia in a ceremony also addressed by Premier of Western Australia, The Hon. Colin Barnett MLA, Commonwealth Secretary-General H.E. Kamalesh Sharma, Commonwealth Foundation Chair, Madam Simone de Comarmond and Commonwealth People's Forum Chair, Ms Sue Ash.

Western Australian Premier Colin Barnett said the mark of any civil society was how it treats its most vulnerable in society. Forums like this are important because they provoke debate and remind governments that they can always do better.

Commonwealth Secretary-General H.E Kamalesh Sharma described the Forum as a "vibrant expression of the Commonwealth family in action."

The Forum continues to be a crucial part of the interface between governments and civil society. Central to these discussions is a powerful statement from civil society representatives of the 54 member association calling on Heads of Government to act urgently to strengthen the role of civil society so that the Commonwealth can become a "meaningful vehicle for change."

300 accredited delegates from Australia and the wider Commonwealth debated the issues raised in the statement which they presented during the round table dialogue between civil society representatives and Commonwealth Foreign Ministers on Thursday 27 October in Perth. The theme for CHOGM 2011 was "Building National Resilience, Building Global Resilience", which reflected the importance of addressing pressing challenges at multiple levels: as individual states, as members of the Commonwealth, and as part of the global community.

During their retreat the Heads of Government discussed sustainable development, the threat of climate change for large and small states, developed and developing, also recognised that food security is one of the most difficult and pressing challenges facing the world and issues facing small states. The leaders agreed that there should be a charter of the Commonwealth by 2012. This was a central recommendation of the Eminent Persons Group's (EPG) report. There will be a process of consultation on the content of the charter as was recommended by the EPG. The charter will bring together the Commonwealth's values, principles

and aspirations in one clear and powerful statement.

There are 104 recommendations in all. The leaders have asked foreign ministers to do some further work on the other 102 recommendations

The Commonwealth People's Forum had space for eight one day workshops and fifteen learning journeys.

Doris Bingley participated in the Gender & Women's Rights Assembly. She made a presentation at the Gender meeting on our role in Europe. Gender equality is one of the fundamental principles of the Commonwealth. The Commonwealth Plan of Action for Gender Equality (PoA) 2005-2015 provides the framework within which organisations can contribute to advancing gender equality in Commonwealth countries. This workshop explored mechanisms for taking forward the recommendations of the PoA Review and how these can be supported.

Doris Bingley also contributed to the Education, Technology & Innovation Assembly. She distributed papers from Malta's Ministry of Education on e-learning initiatives that the Maltese Government has in place to make technology accessible and user friendly for teachers and students as this government wants to ensure that students are ready for the knowledge based economy that awaits them.

Grace Attard was for many years a teacher of various subjects. She furthered her studies and taught in Prevention Services in the Community, Parenting Skills, Personal and Social Development (PSD), Media Education and Career Guidance.

She has served as President of the National Council of Women (NCW) for two terms. She is a regular contributor to local media on social policy and gender Issues, particularly on the early detection of domestic violence and the promotion of gender equality in political and economic decision making. Through research and dialogue with social partners, she has submitted proposals for family-friendly and social security measures.

She chaired the Working Group on Gender Equality Legislation (2004), and Domestic Violence Legislation (2006), and was a member of the Working Group on Early Childhood Education and on Legislation on the Voluntary sector.

During her Presidency, the NCW was established as a Centre of Learning in ICT, Empowerment of Women, and Lifelong Learning Programmes. The Centre is very active in disseminating information and educating women, especially grassroots on various gender equality issues

Grace Attard has been a member of the EU Commission Advisory Committee on Gender Equality, working on women in the media, the role of men in gender equality, and women in research and science.

She has been very active in raising awareness of participative democracy of civil society during Malta's pre-accession period to the European Union.

For the past six years she has represented Civil Society on the European Economic and Social Committee. Grace Attard is an expert in the European Gender Institute, member of the MCESD Civil Society and the National Consultative Council for Enterprise, and is the co-chair of the Committee on Women in Research and Science within the Malta Council for Science and Technology.
